# Rabbits

#### Entries must be received by Friday, July 11, 2025. NO POST ENTRIES. NO WALK-INS ACCEPTED. All entries MUST supply heavy weighted food and water dishes or entry will not be accepted.

#### **RULES & REGULATIONS**

- Rabbits will be accepted on Friday, July 25, from 8:00AM until 3:00PM. All animals must be cooped in by 3:00PM on Friday. All livestock EXCEPT Horses must enter and exit Gate 2 on the hill. Only Horses use Gate 1. Early delivery is available on Thursday, July 24 from 4:00PM-8:00PM.
- 2. Rabbit Judging will be held on Saturday at 9am. All entries will be judged by the American System. Judge's decision is final.
- 3. There will be two divisions, Open and Juniors. Juniors must be 16 years of age or younger. Same prize money and ribbons will be given.
- 4. All exhibitors will be given a one day pass at the time of coop in. Please do NOT lose your pass.
- 5. ALL entries MUST remain in place until 6pm on Sunday. Any animals removed before 6pm will result in the forfeit of all money & ribbons awarded.
- 6. Rabbits MUST be at least 8 weeks old.
- 7. NO does with litters will be accepted.
- 8. Feed, water and bedding will be provided for all animals.
- 9. Entries are limited to 8 rabbits per person or when pens are full. If rabbits can be housed together during fair, please note on entry form.
- 10. If exhibitors wish to sell rabbits they MUST be present at the time of sale and make necessary arrangements with the purchaser for the removal at the proper time. No animals can be removed until 6pm on Sunday. Sale signs shall be no larger than 3"x 5".
- 11. The Lebanon Country Fair and the Superintendent are not responsible for any death, loss, fire, injury or stolen animals.

## Poultry & Waterbowl

#### Entries must be received by Friday, July 11, 2025. NO POST ENTRIES. NO WALK-INS ACCEPTED.

Rules & regulations set forth by the State of Connecticut Department of Agriculture will be observed. The final decision on the health of poultry will be determined by the Superintendent.

- \*SEC.150-3-2: Only healthy adult birds may be shown.
- \*SEC.150-3-3: All entries to the show or exhibition shall be accompanied by a declaration or certification from the owner or exhibitor that, to the best of his/her knowledge, the poultry entries are free from any evidence of and were not recently exposed to Newcastle Disease or any other infectious or transmissible disease.
- \*SEC.150-3-5: All crates, boxes or containers, and vehicles used to transport the poultry to the show shall have been thoroughly cleaned and disinfected. All poultry MUST be pullorum tested and found NEGATIVE within the last twelve months, with a card of approval from Livestock Division for out-of-state exhibitors.

#### **RULES & REGULATIONS**

- Poultry will be accepted on Friday, July 25, from 8:00AM until 3:00PM. All animals must be cooped in by 4pm on Friday. All livestock EXCEPT Horses must enter and exit Gate 2 on the hill. Only Horses use Gate 1. Early delivery is available on Thursday, July 24 from 4:00PM-8:00PM.
- 2. Poultry Judging will be held on Friday at 6pm. All entries will be judged by the American System. Judge's decision is final.
- 3. All exhibitors will be given a one day pass at the time of coop in. Please do NOT lose your pass.
- 4. ALL entries MUST remain in place until 6pm on Sunday. Any animals removed before 6pm will result in the forfeit of all money & ribbons awarded.
- 5. Feed, water and bedding will be provided for all animals.
- 6. Entries are limited to 8 birds per person / 30 birds per family. If animals can be housed together during fair, please note on entry form.
- 7. If exhibitors wish to sell their animals they MUST be present at the time of sale and make necessary arrangements with the purchaser for the removal at the proper time. No animals can be removed until 6pm on Sunday. Sale signs shall be no larger than 3"x 5".
- 8. The Lebanon Country Fair and the Superintendent are not responsible for any death, loss, fire, injury or stolen animals.
